Vice President --- Assist president with duties in their absence. Includes promoting, coordinating volunteers, and documenting events with committee chairs, assists in recruiting any needed positions. Board position is a commitment of 2 years, has a potential of 2 positions available at one time, and is subject to members vote and approval of current board and school administration.

Treasurer ---- Responsible for keeping detailed and balanced accounting. Works closing with the schools' business manager. Must supply a monthly/quarterly balance sheet to PTU board and school administrators.
